

**REQUEST FOR PROPOSALS
FOR AIRPORT FINANCIAL CONSULTING SERVICES
STATE OF HAWAII
DEPARTMENT OF TRANSPORTATION

(Chapter 103D, HRS)**

The State of Hawaii Department of Transportation, Airports Division (hereafter referred to as the "DOTA"), is requesting proposals from qualified Offerors to provide airport financial consulting services related to airports rates and charges, capital and financial planning, bond feasibility studies to support the issuance and management of Airports System Revenue Bonds ("ASRB"), Customer Facility Charge Revenue Bonds ("CFC Bonds") and other obligations, and other airport management and financial consulting services. The Offeror must be a legal business authorized to do business in the State of Hawaii, among other minimum requirements. This contract would be a three (3) year engagement.

The DOTA is located at the Daniel K Inouye International Airport (HNL), Inter-island Terminal Building. The DOTA services all 15 airports in Hawaii Airports System (i.e., Oahu District (3 airports), Maui District (6 airports), Kauai District (2 airports), Hawaii District (4 airports)). In the fiscal year ending June 30, 2019, approximately 18.7 million passengers enplaned at the airports in Hawaii Airports System.

Any Offeror that submits a proposal must, at the time of contract award, provide the State of Hawaii with the following:

1. A tax clearance certificate from the Hawaii State Director of Taxation and the Internal Revenue Service to the effect that any delinquent taxes, interest, and penalties levied or accrued against the said Offeror have been paid, and/or any other evidence acceptable to the contracting officer to demonstrate that the Offeror is not in default on any obligations due to the State of Hawaii, any of its political subdivisions, and the Internal Revenue Service.

2. A compliance certificate from the Hawaii Department of Labor and Industrial Relations.
3. A copy of its certificate of good standing from the Hawaii Department of Commerce and Consumer Affairs.

Each proposal shall be in the format established in these specifications.


