REQUEST FOR PROPOSALS FOR FFY2021 FREEWAY SERVICE PATROL STATE OF HAWAII DEPARTMENT OF TRANSPORTATION PROJECT NO. NH-0300(167) (Chapter 103D, HRS)

The Hawaii Department of Transportation, Highways Division (HDOT) is requesting proposals for the operation of its FFY 2021 FREEWAY SERVICE PATROL (FSP) Program, Project No. NH-0300(167). Sealed Proposals will be received at the Contracts Office, Department of Transportation, 869 Punchbowl Street, Room 105, Honolulu, Hawaii 96813, until 2:00 P.M., Hawaii Standard Time (HST), on February 25, 2020.

Offerors will be responsible for providing a turnkey service that includes the staffing, equipping, operating and managing of the FSP Program. The program will operate roving service patrols on Interstate Routes H-1, H-2, and H-201 on the Island of Oahu, Monday through Friday from 4:45 A.M. to 7:15 P.M.. This contract would be a four (4) year engagement with a possible one (1) year extension.

Any Offeror that submits a proposal must, at the time of contract award, provide the State of Hawaii with the following:

1. A tax clearance certificate from the Hawaii State Director of Taxation and the Internal Revenue Service to the effect that any delinquent taxes, interest, and penalties levied or accrued against the said Offeror have been paid, and/or any other evidence acceptable to the contracting officer

- to demonstrate that the Offeror is not in default on any obligations due to the State of Hawaii, any of its political subdivisions, and the Internal Revenue Service.
- A compliance certificate from the Hawaii Department of Labor and Industrial Relations.
- 3. A copy of its certificate of good standing from the Hawaii Department of Commerce and Consumer Affairs. Alternatively, Proposer may collectively apply for the certificates described as Items 1, 2, and 3 above through the Hawaii Compliance Express (HCE). The HCE allows businesses to register online through a simple wizard interface at http://vendors.ehawaii.gov to acquire a "Certificate of Vendor Compliance." The HCE provides current compliance status as of the issuance date. The "Certificate of Vendor Compliance" indicating that vendor's status is compliant with the requirements of HRS §103D-310(c), shall be accepted for both contracting purposes and final payment. Vendors that elect to use the HCE services will be required to pay an annual fee of \$12.00 to the Hawaii Information Consortium, LLC.

Each proposal shall be in the format established in these specifications.

Campaign contributions by State and County Contractors. Contractors are hereby notified of the applicability of Section 11-355, HRS, which states that campaign contributions are prohibited from specified State or County government contractors during the term of the contract if the contractors are paid with funds appropriated by a
