Responses to Question Raised by Applicants For RFP-HMS-501-25-05, Community-Based Outreach and Advocacy Services

1. Regarding geographical coverage, currently Outreach and Advocacy Services contracts were separated by OYS to serve different districts in Oahu. How is this RFP's geographical coverage set up? Will it be split into districts?

The purchasing agency does no plan to separate and award by district.

- 2. **If a provider gets awarded, will it be serving the whole island?**The provider would need to specify the geographical location it proposes to serve. If the proposal specifies serving island-wide, and if awarded, the basis for award would be island-wide service coverage. If a proposal specifies serving specific districts within an island, and if awarded, the basis for award will be to provide services in the proposed district(s).
