The project involves reconstructing the roadway pavement of Elilani Street and Kilani Place, cold planing and resurfacing a portion of Elilani Street, and replacing three culverts on Elilani Street. The scope of work includes road resurfacing; road reconstruction work; culvert replacement, CRM headwall reconstruction, pavement striping and markers; adjustment of water valves; replacement of signs; and other incidental items.

All prospective bidders or their representatives (employees) are encouraged to attend, but attendance is not mandatory. To be eligible to bid, bidders must be licensed in accordance with Chapter 444, HRS, relating to the licensing of contractors.

The Hawaii Products Preference pursuant to Act 175, SLH 2009 is applicable to this project. Persons wishing to certify and qualify a product as a Hawaii Product shall submit a Certification for Hawaii Product Preference (SPO form 38) for each product to Purchasing Division no later than September 30, 2019. Late submittals for this solicitation will not be reviewed by the County.

Contractors are hereby notified of the applicability of Section 11-205.5, HRS, which states that campaign contributions are prohibited from specified State or county government contractors during the term of the contract if the contractors are paid with funds appropriated by the legislative body.
