

SPECIAL PROVISIONS

1. To Furnish and Deliver One (1) ½ Ton 4x4 Crew Cab 4 Door and Pipe Rack for the Department of Water Supply, County of Maui, shall be subject to the Minimum Specifications, Special Provisions, Proposals and General Conditions (Bid Documents) in this order of priority.
2. Bid prices shall include all costs, insurance, taxes (except Federal Excise Tax from which the County is exempt) and freight/delivery charges F.O.B. Base-yard of the Department of Water Supply at 614 Palapala Drive in Kahului, Maui.
3. Bidder must complete the appropriate proposals, enclosing current literature describing the vehicles and available options.
4. The Director reserves the right -
 - a. to accept or reject any or all bids and to waive any minor or inadvertent discrepancy in the bid documents;
 - b. to withhold award of contract for a period of thirty (30) calendar days from the date of bid opening; and,
 - c. to increase or decrease the quantities anytime prior to award of contract and vendor agrees not to claim loss of profit from the changes.
5. No withdrawal of bid will be allowed after the bids are opened.
6. Bidder shall deposit his bid with the Purchasing Agent, Department of Water Supply, 5th floor of the Kalana O Maui (County Building) in Wailuku, Maui, Hawaii.
7. Bids must be in our hands by 10:00 o'clock a.m. on the date designated for the bid opening. Bids mailed and postmarked earlier than the date and time specified for bid opening but received later will be rejected.
8. Delivery date shall be computed from the Official Commencement Date specified in the "Notice to Proceed" issued by the Director.
9. Vehicles must be delivered fully fueled and operational, to include the securing of license plates and safety inspection stickers prior to delivery to the DWS Base-yard at 614 Palapala Drive, Kahului, Maui, Hawaii.
10. Award of contract will be based upon the TOTAL PURCHASE PRICE.

11. Bidder must meet the requirements of Section 437, Motor Vehicle Industry Licensing Act, Hawaii Revised Statutes. A space is provided in the proposal for the License Number issued by the State of Hawaii.
12. Bidder must maintain or be able to contract for factory authorized service facilities or facilities capable of meeting factory standards as determined by the Director on the island of Maui to service and repair the vehicles offered. A letter confirming this service arrangement shall be attached to the proposal.
13. As a prerequisite for entering into a contract Bidders shall submit a current Tax Clearance, Certificate, Certificate of Good Standing, and Certificate of Compliance by using the Hawaii Compliance Express, which allows businesses to register online through a simple wizard interface at:

14. Each bidder awarded a contract is required to submit tax clearance upon final payment.
15. Liquidated Damages. The seller recognizes and agrees that time is of the essence under this agreement and, due to the speculative character and difficulty of ascertaining damages to the Department of Water resulting from any delay beyond controversy and dispute, will agree that the seller shall pay to the Department of Water the sum of ONE HUNDRED AND NO/100 DOLLARS (\$100.00) as liquidated damages and not as a penalty for each day that furnishing and delivery of the material contemplated in this agreement remains uncompleted beyond the time set herein for completion; provided, however, that the remedy of liquidated damages shall be in addition to any other rights and remedies otherwise available to the Department of Water and not expressly waived herein.

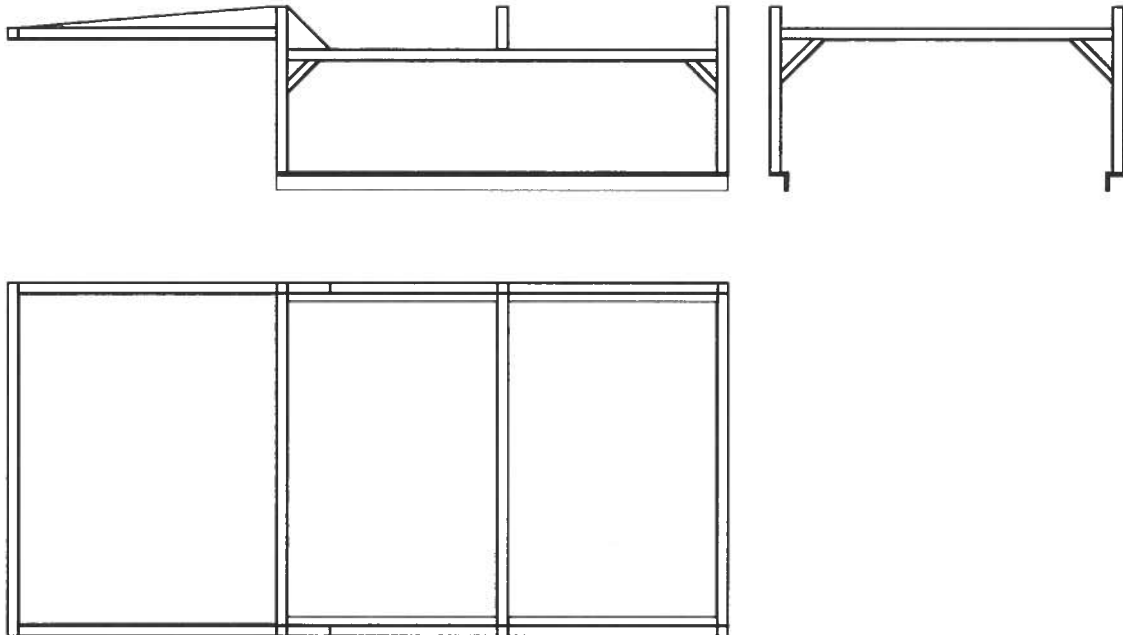
